We received a PPP loan for \$47,234, that covered payroll in FY20 that would not affect our FY21 Resort Tax request. We also received a \$10,000 grant from the State of Montana, funded through federal emergency relief funding through the Coronavirus Aid, Relief, and Economic Security (CARES) Act. This grant helped fill the revenue gap created by the 25% reduction in our operations from the Spring Resort Tax request and does not impact our FY21 Fall request.

COVID-19 Impact*

What has the impact of COVID-19 been on your operation and how has this impact affected your Fall Resort Tax request?

Developing our FY21 request, we did so with COVID-19 and community needs in mind, making deep budget cuts, asking for much less than recent previous BSRAD allocations. At the onset of COVID-19, we took a financial and programmatic hit in returning \$47k of our FY20 BSRAD allocation for Big Sky Relief. Due to COVID-19, BSRAD also indicated the need to cut our Spring FY21 request by an additional 25% from our operating costs, resulting in further tightening of budgets and reducing impactful programs/projects. We lost an extra (minimum of) \$72,500 revenue from event sponsorships and grants from local/regional organizations that couldn't support because of COVID-19. Delaying our annual fundraiser to August, reduced planned revenue for FY2020 by \$150,000. We have made up for some revenue loss through COVID-19 relief programs like the PPP loan, which we hope to be a grant. We've been limited in our ability to engage directly with new donors/supporters with events being cancelled or modified, including: fly fishing films, volunteer events, annual fundraisers, and dog waste/river cleanups. Engaging with donors and leaders in person is key to our success and relevancy. COVID-19 restrictions have damaged our ability to increase and expand donations/new donors through in-person events. Unexpectedly, COVID-19 has created more urgency to our project work with large increases in summer resident stays (many becoming full time), increased overall Big Sky resident population, and the emphasis of enjoying the outdoors during the pandemic. While we advocate for sustainable development, local real estate demands and plans may be outpacing the current water and wastewater infrastructure in Big Sky. Such changes are putting enormous pressure on our water resources, water quality and availability; and expedite the need to address threats like: increased erosion/vegetation damage along the Gallatin, surging water withdrawals from groundwater with recent reports of residential well-water dropping, warmer water temperatures, and reduced streamflow. These conditions along with others, have contributed to the Gallatin experiencing its second large scale algae bloom, and if unaddressed by our community, without greater funding from all entities (public and private), could be detrimental to the Gallatin River, our watershed and water supply.

Numbers correspond to goals outlined above :

- 1. We elected a new board chair, Ennion Williams and are actively recruiting 4 additional board members. We have increased our board size to allow for additional leadership and to not overstretch current board members.
- 2. We quickly replaced an open full-time staff position with a part-time employee and a contractor in order to continue our work and help make up for revenue losses in budget cuts. We also eliminated COLA raises from our budget this fiscal year and restricted benefits while supplementing our new operational handbook with added benefits for time off, etc.
- 3. With COVID restrictions, it was difficult to expand our volunteer workforce but we did recruit 106 volunteers who worked 938 hours to expand our capacity as needed for water quality monitoring, fly fishing

camp, fundraising event, and river cleanup. We consider this to be an incredible feat in a time where we, as a science based organization--have strictly abided by COVID restrictions.

- 4. We continue to build and maintain positive relationships with partners, stakeholders, and donors.
- 5. We have developed a draft strategic plan/business plan and communications plan for moving forward a long-term source of funding to assist with operations and building water supply resiliency. We have rapidly expanded our grant applications to new groups, letters of inquiry(s), and grant research processes to add dozens more opportunities into our potential pipeline of revenue generation. This has included a focus on more national & regional organizations focused on the issues of water conservation & river restoration, and other areas aligned with our work & mission.
 - 6. We developed and began implementing annual budget, fundraising plan, and work plans
- 7. We have developed and improved systems of financial and employee records that include new credt card processing systems, employee budget racking, and transitioning to digital record management
 - 8. We recruited two AmeriCorps member and one intern to assist with capacity
- 9. We are in the process of building structures, policies, and procedures that facilitate effect organization growth through restructuring our organizational chart and the staff roles as well as the transitioning from a working board to a governing board.

In addition, our operations were critical to develop additional revenue streams, and plann, and execute all other projects and programs supported by Resort Tax and others.

What additional information would you like to share with the Board regarding this project/program?

We are requesting \$29,000 that was cut from our FY21 Spring Ops request to make up for that loss & align with the community vision of funding our natural environment. Additionally & outside of the scope of most conservation orgs, we advance infrastructure for Big Sky that supports/restores the watershed, tackle issues concerning river recreation, & fill the void on planning/water use issues where a local incorporated municipality would otherwise lead. We don't feel the scope of our work was considered with cuts. We had already sharply cut our initial FY21 request compared to previous years re: COVID. Our FY21 operations request before cut, was 26% less than FY20 & lowest % of our operational budget we have ever requested from BSRAD: 45% vs. 60%+ in years prior. The further 25% cut has harmed planning for and developing crucial programs/projects to address water issues. It's our continued goal to lower requests annually as we find new, sustainable revenue sources beyond BSRAD.

To meet the goals outlined in our Spring application, we launched a strategic communications plan focused on raising community awareness around water-quality and water-quantity issues, and on our projects and their outcomes. The strategy had a digital focus for better tracking, but also recognized Big Sky's unique market and the need to promote our work locally and in person as much as possible given COVID constraints. We incorporated added flexibility into our community outreach efforts to maintain public safety while still growing our impact. By doing so, we reached more volunteers, cleaned more miles of river, and collected more pounds of trash than in years previous, adapting to the circumstances without compromising our ability to achieve our mission. From a communications perspective, a digital-first strategy maximized our

reach and growth of our audience, even within the challenging social and political landscape of the past six months. Detailed planning increased and expanded our earned media coverage to new outlets, growing our audience efficiently. For example, taking our Hooked on the Gallatin banquet virtual was the only way to plan for success, and adopting a primarily digital promotion strategy allowed us to reach a new audience of donors and supporters, increasing membership and reach into new communities sympathetic to our work. As it currently stands, the Task Force has for the first time, over 200 active Friend of the Gallatin members, with plans to continue outreach to new members over the next 6 months, increasing membership through engagement of new community members that have arrived/become permanent residents. We also launched our new license plate program with the Montana DMV, which will continue to be developed and grown to ensure a minimum of 400 License Plate holders in the state to maintain/keep as a sustaining source of outreach/revenue. We are already nearing 100 plate holders, with only a few months of outreach behind us. Other measurable outcomes include:

Nutrient Abatement Feasibility Studies: To date we are under contract and have had a site visit with the contractor, who will develop a design for a wetland treatment system to reduce nutrient loading to the West Fok. Design will be completed this fall with expected measurable outcomes as delineated in Spring application.

Upper Deer Creek & Porcupine/Beaver Creek:

The Upper Deer Creek Project is currently under construction. River access improvements will be completed by the end of October with revegetation of the streamback occurring in Spring 2021. Measurable goals include:

The Porcupine/Beaver Creek Project is currently in the design & engineering phase. A wetland delineation will be completed in October 2021 and 35% engineered plans will be completed by April 2021. This project will have similar ecological and recreational benefits as the Upper Deer Creek Project.

River Cleanup: 70+ Task Force volunteers collected 2,260 pounds of trash along 40+ miles of river. Given COVID constraints, we met our goal by adding flexibility to the event, giving volunteers three days to collect trash instead of just three hours. This socially-distant approach yielded a better outcome than previous years and will be incorporated into future plans.

We are currently working on a restoration planning effort with the Forest Service that we will present to the public for input over the winter/arly spring. This plan will guide our restoration priorities along the Gallatin corridor for the next ten years. In addition, we are in the process of finalizing an updated and expanded Upper Gallatin Nutrient Reduction plan that will guide our project priorities to address nutrients and mitigate algae blooms. The River Cleanup continues to be one of the most impactful ways to show the need for conservation and environmental protections for the Upper Gallatin Watershed. Volunteers are routinely struck by the volume of trash throughout the upper river corridor, and recent rapid growth has only exacerbated the problem. In the future, multiple cleanups will likely be necessary to keep pace with increased visitation and population growth.

Town Center Purple Pipe: 290 linear feet of purple pipe was installed in the town center that once hooked up to the Big Sky Water and Sewer District reuse system will reduce over 5 Million gallons of clean groundwater from being withdrawn for irrigation, add an additional 5 Million gallons of disposal option for treated wastewater effluent for the Big Sky Water and Sewer District, and provide the Big Sky Community Organization with reuse water required for BASE LEED certification.

Water Conservation Program: The Big Sky Water Conservation Program incentivizes community members to engage in practices that save water via indoor and outdoor rebates on water efficient fixtures, free showerhead swap, and Trout-Friendly Landscape Certification.

- The Upper Gallatin River basin possesses a finite water supply that could be surpassed as the demand for water increases with community growth and predicted climate variability.

With minimal annual precipitation, Big Sky's semi-arid climate relies on snowpack for its water needs.

- According to the 2017 Montana Climate Assessment, Montana's snowpack has declined since the 1930s. Warming temperatures over the next century, especially during spring, are likely to reduce snowpack at mid and low elevations. Rising temperatures will likely exacerbate drought when and where it occurs particularly affecting rural water systems.
- Montana is one of only two states with very high vulnerability to drought, according to the National Integrated Drought Information System's national assessment.
- Drought can be a contributing factor to wildfire. Dry, hot and windy weather combined with dry vegetation and a spark -- either through human intent, accident or lightning -- can start wildfire.

Addressing and coordinating stormwater management across Big Sky was a prioritized strategy in the Big Sky Sustainable Watershed Stewardship plan from both a water quality and water quantity perspective. Development compacts soils and adds impervious surface, resulting in snowmelt and rain running off the surface faster and earlier than in natural conditions. Earlier and faster runoff, reduces groundwater recharge threatening public water supplies and reduces late summer streamflows threatening fisheries health. Climate change predictions for this area is expected to exacerbate both of these conditions. Through strategically targeted and coordinated stormwater management, we can "store" runoff to be released at time when when it is needed most. We are requesting Resort Tax for 50% of the project cost and will be working to solidify the remaining 50% from private donors and foundations.
