- **DB** kicked off the meeting, welcomed participants, and gave meeting background and details.
- **DB** provided an overview of the "Our Big Sky" Plan, how we got to where we are today, and the path forward.
- **CW** provided an overview of "Elevate Big Sky", a collaboration between BSRAD and the local community foundations and a collective impact model for meeting the needs of the community.
- **DB** let the group know that the "support team" for the council are Jenny and Ruthi.
- **RS** led the group through a discussion around the Strategies that were flagged for needing more definition, detail, or any modifications.
 - Embrace Big Sky's DNA as a Destination, Born Out of a Visitor Economy → Destination
 Development and Management
 - Improve and Maintain Infrastructure → Improve and Maintain Water & Sewer
 Infrastructure, Improve and Maintain Transportation Infrastructure, and Improve and
 Maintain Energy and Telecommunication Infrastructure
 - Increase Transportation Options to Serve Recreation and Mobility → Now included the new Improve and Maintain Transportation Infrastructure Strategy
 - Preserve a Cohesive but Distinct Character Throughout the Community → Remove from list at Initiatives are covered in several other Strategies but have a discussion with the Planning and Zoning Committees (both counties).
 - Provide Transparency/Engagement and Governance Options → Transparency and Engagement are both values of the group therefore strike the Strategy.

- The group broke out into smaller working groups to discuss report cards and create partner and initiative lists for each Strategy.
